ANNUAL GENERAL MEETING

ORDINARY BUSINESS

Resolution 1 Approval of Annual Report and Accounts

The directors are under a duty in respect of each financial year to lay the accounts and the reports of the directors and the auditors before the Company in General Meeting. This gives shareholders the opportunity to ask questions on the contents of the Annual Report and Accounts for the period to 2 October 2010 before voting on the resolution.

Resolution 2 Remuneration report

The Directors' Remuneration Report Regulations 2002 ("the Regulations") require the Company to produce a yearly report on directors' remuneration and to put an annual resolution to shareholders for approval of that report. Resolutions 3, 4 and 5 Reappointment of directors
