

Markets - Chesterfield BioGas

- Cleaning biogas from waste water treatment and anaerobic digesters to give fuel grade methane
- 5 year licence signed with Greenlane® Biogas for supply of upgrading equipment
- No technology risk
- Two areas of use: vehicle fuel and injection into the gas grid (BtG)
- Significant pipeline of projects covering waste water treatment, food processing, agri-industrial and transport sectors
- Growing pipeline for refuelling stations with local authorities
- Grid injection projects awaiting announcement on RHI
